## About the Foyer Gallery

Run by the Foyer Gallery Artists Association, the Foyer Gallery promotes local artists, offering to members in good standing at least eight all-member shows per year and one four-person show every second year. Up to 5000 people visit the Foyer annually, and its glassed-in space allows passersby to view the art during off-hours. In addition, members benefit from other opportunities and services provided on an ad-hoc basis.

**Your responsibility as a member of an artist-run gallery will include payment of annual membership dues of \$100, as well as a 15% commission on the sale of artwork, spending two 3-hour shifts per month gallery sitting and 2 hours a month (or equivalent) doing committee work. Applicants must be able to communicate with gallery visitors in at least one of Canada's two official languages (English or French).**

## Jury Process

Applications are juried in an arm's length peer review by three professional artists. Acceptance is based on originality and excellence of the art work, coherence of the body of work and style AND the applicant's willingness to participate in the mandatory responsibilities of the Foyer Gallery.

## Application Requirements

Please submit the following by 4:30 p.m. on Friday, October 29, 2010.

1. A \$25 non-refundable jury fee (cheque made payable to the Foyer Gallery Artists' Association, or FGAA).
2. A signed application form and statement of authenticity.
3. One copy of your artist's CV and three (3) copies of a brief (100 words) artist's statement.
4. Ten (10) digital images on CD or DVD showing your work done within the past two years. The images must be JPEG and PC-compatible only with no more than 1024 pixels (300 dpi) on the longest side. Label each image with a number from 1 to 10 and the title of the work (e.g. 1-title).
5. Provide three (3) copies of a correspondingly numbered list of the images with the title, dimensions and medium.
6. If you want your documents returned to you, include a self-addressed envelope big enough to hold them and sufficiently stamped to cover mailing costs.

NB: Image quality is extremely important.

Applicants will be notified of the jury's decision by the end of November, 2010. Jury decisions are final.
